Re San Antonio airtel to Bureau, 1/5/63.

Referenced San Antonio airtel incorrectly quotes (on page three, paragraph one), from a prior Dallas airtel submitted to the Bureau, 12/10/62, information received by the Dallas Division from an informant. The San Antonio airtel states "An informant of the Dallas Office....," and also refers to this source in reairtel, as "unidentified". In actuality, the source is fully identified on page three of the Dallas airtel, by symbol number and Dallas file number. In order to further identify the informant's source of the information, investigation was conducted by the Dallas Division, with the result that this source was tentatively identified, as set out in detail, also on page three of the Dallas airtel.

The Dallas informant is a qualified, symbol informant, who has furnished reliable, pertinent information on numerous occasions in the past, or else he would not be a symbol informant, nor would contacts be continued by the Dallas Division with this informant. It is further pointed out to the San Antonio Office that the information received was of criminal intelligence in nature and that the informant stated, as clearly set out on

on page four, that he, the informant, could not "vouch" for the information. The information was evaluated by the Dallas Office, and thereafter disseminated to the Bureau and other FBI Offices in Texas, as a matter of cooperation, and for intelligence purposes. The motive for DL-170-C furnishing the information is believed to be that he is an informant, and as such is furnishing all information received by him to the FBI, which is as it should be. The accuracy or inaccuracy of the information could not possibly be known by the Dallas Office, or any other office, at this time--only the possibility of such could be known. It has always been the policy of the Dallas Division, in connection with captioned program, to furnish the Bureau and any offices having an interest, all criminal intelligence information received, based on the premise that intelligence type information is only of value when received, recorded and disseminated expeditiously.
