Re Dallas letter to Bureau, 2/8/63.

On 2/20/63, following their arrest by Dallas Police Officers, on charges of bookmaking, and on information furnished the PD by the Dallas Office, MARVIN C. COX and SHERMAN FRANKLIN LITTLE were interviewed by Bureau Agents. COX is a runner for LITTLE's bookmaking operation in Dallas, and LITTLE is the subject of Dallas file 162-129, captioned "SHERMAN FRANKLIN LITTLE, aka., IGA," Dallas origin.

Both men were very uncooperative and non-committal and refused to discuss their bookmaking activities whatsoever. In fact both disclaimed any such activity on their parts.

On 2/28/63, [redacted] subject of Dallas file 165-103 was interviewed by Bureau Agents at his used car lot, Dallas. [redacted] was very cordial and appeared to be cooperative. He admitted acquaintanceship with numerous Dallas area gamblers and bookmakers, and furnished pertinent background information as to gambling in the Dallas area. Prior to the interview no information had been developed that [redacted] was in violation of any Federal anti-gambling statutes. The ITWI investigation has been discontinued and a new 137 case re [redacted] has been opened by the Dallas Office.

OTHER 4

On 3/6/63, WILLIAM HOWARD COOPER, subject of Dallas file 162-208, was interviewed by Bureau Agents at his place of business, a Dallas private club. This was the second interview of COOPER. Information developed by the Dallas Office, that could cause local authorities to take action against COOPER's private club operation, was made known to COOPER.
