ALDERISIO's arrest record shows fingerprinted 10/31/42, Chicago, Ill, ASN 36 706 435. Miami presumes Chicago has probably already checked ALDERISIO's service record. If such was done, advise Miami results of same, otherwise request St. Louis to check same immediately.
