FETZNER contacted MM 830-C, who stated that the check-in and check-out register at the Fontainebleau Hotel is maintained for a maximum of only two months and thereafter destroyed. The informant stated the only permanent record of a person who registered at the Fontainebleau Hotel is the hotel registration card and these cards are filed alphabetically.
