Will continue to coordinate efforts to bring about the apprehension of subject MANOCCHIO.

Will follow and report further prosecutive action re subject VENDITUOLI.

ADMINISTRATIVE

On 6/29/71, CG 7190-C and CG 7287-CTE were contacted regarding associates and contacts of MAX INSERRO and the possibility of MANOCCHIO being in contact with INSERRO with negative results.

On 7/16/71, BS 1131-PC advised SA MARTIN P. CONLEY that MANOCCHIO was very close and intended to marry a former actress or showgirl, who was a divorcee and has two children. Source heard that MANOCCHIO still in contact with this woman. He advised that he does not know the name or address but would attempt to uncover this information.

BS 1745-PC on 9/7/71, advised SA ALBERT P. KOEHLER that he believed that PETER BARILE, 425 New Boston Road, Fall River, Mass., may know where MANOCCHIO is staying. He advised that he would attempt to obtain this information and report on same.

BS 1745-PC on 10/14/71, advised SA ALBERT P. KOEHLER that FRANK VENDITUOLI is getting "very edgy" about being in jail and he is attempting to put together a defense for a pending state trial. On 10/20/71, same source advised that VENDITUOLI wanted PETER BARILE provide an alibi for him on the night of the murder and BARILE has agreed to go along with the plan and has been in contact with VENDITUOLI'S attorney concerning this defense.
