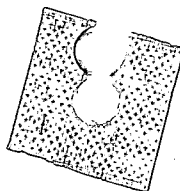

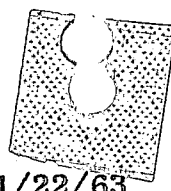

WEEKLY SUMMARY

MM 730-C advised that MAX EDER (MM 92-467) has some authority at the Fontainebleau Hotel, Miami Beach, Fla., particularly in the various bars and clubs in the hotel. He also reported that BEN SHERMAN, regarded as an "EDER man", has more or less an established betting clientele among the employees of the Fontainebleau Hotel.

MM 814-C advised that if MAX EDER "goes to bat" for anyone who is fired by the hotel, that person is re-employed. He stated the captain of the waiters, the waiters, bell boys and cabana boys are all close to EDER and it has been said many times that they are his "boys".

MM 509-C-TE advised that he was told by some of the football parlay cards (MM 165-177) sellers that they are securing larger bets this year on these cards. He stated for example last year they generally received \$2.00 to \$5.00 bets whereas this year they are receiving \$10.00 and \$20.00 bets.

MM 883-C-TE advised that he received information that the building formerly occupied by the B.P.O. Elks Club at 887 E. Okeechobee Rd., Hialeah, Fla., was reconditioned and a new gambling club opened, called the Union Club. He stated membership cards are used and signed by ARMANDO SUAREZ. He pointed out that this individual has no status and is only an
