The following information was received 6/6/67 from JORGE VAZQUEZ ROBLES, Chief of the Inspection Service of Mexican Immigration (Gobernacion), an important contact of this office. This information should not be reported for dissemination.

As has been previously reported subject was presented in Mexico by Attorney JORGE CASTILLO Z., Plaza de La Republica #32, Mexico City. He has been characterized by source as a responsible attorney specializing in immigration matters and is in frequent contact with high officials of Mexican Immigration.

On 6/7/67 he furnished them with a post card which he claimed to have received from the subject. He also advised that he had received a previous post card from the subject from Palma de Mallorca, Spain, dated about the first of May, 1967. The recent post card appears to be post-marked "Nice R.F., ALPES NARITIMES." The post card has a picture of a girl in native costume and is imprinted "COTE D'AZUR."

The post card reads:
