On 6/30/67, the Police Judiciaire (Criminal Police) Surete Nationale (PJSN), advised that a discreet check by their service had failed to develop any information which would indicate that the subject was in the Nice, France, area on approximately 5/14/67.

The PJSN further advised that the only vessels arriving in Nice on 5/14/67 carrying foreign passengers were the "Comte de Nice," coming from Calvi, Corsica with a normal load of passengers, and an Italian yacht, "Hamal," home port La Spezia, coming from Monaco and destined for Italy. According to PJSN, the "Hamal" is reportedly owned by one GIANFRANCO of Milan, Italy, not further identified. PJSN further advised that subject's name continues to be on their lookout list and should any information come to their attention regarding this individual, our office would be immediately advised.

Legat, Rome is requested to determine, if possible, the full identity of GIANFRANCO of Milan, in an effort to determine if there is any connection between the subject and GIANFRANCO.
