IN STATES" AND EXPECTED TO RETURN FRIDAY, JULY TWENTY EIGHT  
NEXT. SOURCE INDICATED GIANCANA SPENDS MOST OF HIS TIME AT  
RESIDENCE AND AT ADJOINING GOLF

IFICATION POSITIVE. ALSO ADVISE WHAT ACTION MEXICAN AUTHORITIES CONTEMPLATE RE HIS LOCATION THERE. CHICAGO SUGGESTS THAT IT APPEARS PREFERABLE THAT NO ACTION BE TAKEN AT THIS TIME SINCE GIANCANA'S ABSENCE FROM CHICAGO AREA CONTINUES TO DISRUPT ORDERLY AND AGGRESSIVE LEADERSHIP OF CHICAGO HOODLUM GROUP. ALSO SINCE GIANCANA'S WHEREABOUTS ARE NOW KNOWN AND CAN BE COVERED. ALSO ARRANGEMENTS COULD POSSIBLY BE MADE AT LATER DATE TO HAVE GIANCANA EXPELLED FROM MEXICO WHEN SITUATION WARRANTS. (X)u
