Re Chicago airtel 7-13-67, Mexico City airtel 7-27-67,  
BuCab 7-28-67, and report of SA WILLIAM F. ROEMER 7-18-67 at  
Chicago.

As reported, Attorney JORGE VAZQUEZ ROBLES, Chief  
of Inspection Service of Mexican Immigration, advised that  
agents from his office would be making further inquiry at  
the house at Las Nubes No. 2 in Cuernavaca, Morelos, Mexico,  
on 7-28-67.

It is noted that the information which led to the  
location of this house was based on information received  
from the files of the Mexican Immigration Inspection Service,  
and they independently determined the significance of this  
address. It is known that upon orders of the Secretary of  
Government, he had planned to send five agents from his office  
to Cuernavaca to locate HAROLD DERBER. They were to take  
advantage of this trip to also conduct inquiry at Las Nubes  
No. 2 independently.

The DERBER matter became resolved and therefore no  
agents were sent to Cuernavaca on either matter.

In view of the instructions in referenced Bureau cable, Mexican Immigration has been requested to hold any further action in this matter in abeyance. However, it is noted that the Undersecretary of Government has previously shown himself to be personally interested in this matter. If Subject is in Mexico it is in violation of instructions given him and his attorney, and Mexican Immigration may feel constrained to take affirmative action in this matter. It is noted that it has not been definitely established that Subject is in Cuernavaca. If this is positively established, Mexico City feels that to maintain a good working relationship it will be necessary to inform Mexican Immigration of his location. As of this moment, Mexican Immigration still has the matter under advisement. (S) (u)

Mexico City has never considered that CAIN was the "wealthy American" who purchased the house in Cuernavaca. It is assumed that this house was purchased under a false name or under the name of a corporation set up for this purpose, and that CAIN may have lent his name for this purpose. (S) (u)

In view of the information that Subject is a dedicated golfer, contact was established on 7-27-67 with Mr. HARRY WRIGHT, a prominent reliable American and contact of this Office, who is a life-long resident of Mexico, and known to frequent the Cuernavaca area. The problem was explained to Mr. WRIGHT and he advised he would make discreet inquiries over the weekend of 7-29-67 at the golf club in Cuernavaca. On 7-31-67, Mr. WRIGHT advised that he saw no trace of Subject at this club. He advised that he in turn had contacted an American known to him to be reliable, who frequents this club, and this individual is to immediately notify WRIGHT if he sees Subject at the club. (S) (u)

In view of the instructions that Mexico City should use extreme discretion, it is not believed that direct contact with personnel of the golf club would be in compliance with these instructions. (S) (u)

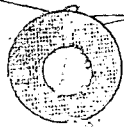
It is noted that the State of Morelos has always been notorious for corruption and that any attempt to work with local authorities there would probably be counter-productive. (S) (u)
