Reference Chicago airtel to Miami, dated 11/1/63:

The Chicago Office is requested to attempt to locate the current address of MORRIE LITBERG since it appears that he, too, was threatened by ALDERISIO in 1960 or 1961.

ALDERISIO SHOULD BE CONSIDERED ARMED AND DANGEROUS SINCE HE IS ALLEGED TO CARRY A GUN IN A SHOULDER HOLSTER.
TRAFFICANTE SHOULD BE CONSIDERED ARMED AND DANGEROUS, DUE TO HIS PAST ASSOCIATIONS IN CRIMINAL ACTIVITIES.
