

Informant advised further that FELIX ALDERISIO himself did not operate the "Hickory Way", a barbecue spot on North 5th Street in Milwaukee but that FELIX's wife operated it for a period of time but the ALDERISIOs have been out of there for a number of years. Informant stated a ROBERT BUNDE worked at the Hickory Way at one time but he does not know whether BUNDE was merely an employee or had a financial interest. Informant advised he knew nothing of BUNDE or where he is currently located.
