ADMINISTRATIVE

For purpose of reporting, this matter is being handled in keeping with the provisions of the ITAR classification with three copies being designated for the Bureau to permit dissemination. One copy is being designated for the USA Office at Miami, and in the event no copy should go to that office since the case is being handled directly by a Departmental Attorney, Miami may so direct.

MI 602-C-TE, who is familiar with hoodlum matters in the Milwaukee area, on 11/27/63 advised SA JOHN H. GASSAWAY that he knows and has been acquainted with FELIX ALDERISIO for some time. He does not know that while in the Milwaukee area that ALDERISIO ever used any names similar to GOODKIND, "GOODIE", GOODY or "Mr. GOODIE" or any close variation. Informant advised further that FELIX ALDERISIO himself did not operate the "Hickory Way", a barbecue spot on North 5th Street in Milwaukee but that FELIX's wife operated it for a period of time but the ALDERISIOs have been out of there for a number of years. Informant stated a ROBERT BUNDE worked at the Hickory Way at one time but he does not know whether BUNDE was merely an employee or had a financial interest. Informant advised he knew nothing of BUNDE or where he is currently located.
