REYES, PSI - UNDER DEVELOPMENT, WHO HAS FURNISHED

RELIABLE INFORMATION IN THE PAST AND WHO IS WELL ACQUAINTED

WITH MEMBERS OF THE MOVIMIENTO INSURRECCIONAL DE RECUPERACION

REVOLUCIONARIA (MIRR), HEADED BY ORLANDO BOSCH AVILA, WHO

HAS ORGANIZED AN AUXILIARY ACTION GROUP KNOWN AS CUBAN SEP 17 1968

ANGULO. BOSCH, DIRECTED ANGULO'S ATTENTION TO FACT THAT A NEWS RELEASE WAS THEN BEING ISSUED FROM MIAMI RADIO STATIONS WQBA AND WFAB RELATIVE TO AN ANNOUNCEMENT BY "ERNESTO" OF CUBAN POWER CLAIMING RESPONSIBILITY FOR A SPANISH SHIP BOMBING. (X)(u)

BOSCH THEN TOLD ANGULO THAT HIS CUBAN POWER WAS RESPONSIBLE FOR THE BOMBING AND THAT THE BOMB WAS SUPPOSED TO HAVE EXPLODED AT THE END OF FIVE DAYS BUT TROUBLE IN THE BATTERIES OF THE TIME DELAY DEVICE CAUSED THE BOMB TO EXPLODE LAST NIGHT. BOSCH ADDED THAT NEXT WEEK "ERNESTO" WILL ANNOUNCE THE APPOINTMENT OF A CIVILIAN DELEGATE FOR CUBAN POWER. BOSCH HAS PREVIOUSLY TOLD ANGULO THAT AS SOON AS HIS GROUP SUCCEEDED IN SINKING A SHIP AT SEA "ERNESTO" (MYTHICAL HEAD OF CUBAN POWER) WOULD ANNOUNCE THE APPOINTMENT OF BOSCH AS THE CIVILIAN DELEGATE. ANGULO, UPON INSTRUCTIONS WILL ATTEMPT TO PERSONALLY CONTACT BOSCH AS SOON AS POSSIBLE TODAY AND ATTEMPT TO OBTAIN MORE SPECIFIC INFORMATION (S)(u)

ANGULO WILL ALSO ATTEMPT TO CONTACT ANDRES JORGE GONZALEZ GONZALEZ, BOSCH'S CHIEF BOMB EXPERT, WHO REVEALED TO ANGULO ON NIGHT OF SEPT. TWELVE THAT GONZALEZ HAD PLACED A BOMB ON A SMALL SPANISH FREIGHTER AT THE SAME PLACE WHERE HE HAD PLACED

ED A BOMB ON THE "LANCASTRIAN PRINCE." INDICATIONS ARE THAT THE BOMB WAS PLACED ON "LANCASTRIAN PRINCE" AT NEW ORLEANS AND POSSIBLY MOBILE. (S)(u)

ON SEPT. TWO LAST, GONZALEZ'S SISTER TOLD ANGULO THAT HER BROTHER HAD LEFT THAT MORNING FOR AN OUT OF TOWN OPERATION BUT DID NOT DISCLOSE HIS DESTINATION NOR DESCRIBE NATURE OF THE OPERATION. GONZALEZ'S WHEREABOUTS UNKNOWN. (S)(u)

FROM SEPT. TWO UNTIL SEPT. TEN, SIXTYEIGHT, WHEN INTERVIEWED BY FBI AGENT AT HIS MIAMI RESIDENCE WHEN HE DENIED HAVING BEEN OUT OF TOWN.

US COAST GUARD, MIAMI, ADVISED THAT THE "SS COROMOTO" DEPARTED BARCELONA, SPAIN, FOR SAN JUAN, P.R., AND ARRIVED SAN JUAN ABOUT SEPT. TEN LAST, WHERE IT REMAINED UNTIL ITS DEPARTURE SEPT. TWELVE FOR DOMINICAN REPUBLIC.

MIAMI WILL IMMEDIATELY FURNISH SAN JUAN WITH PHOTOS AND DESCRIPTIONS OF CUBAN POWER ACTION MEN.

SAN JUAN HAS PREVIOUSLY CONDUCTED INVESTIGATION CONCERNING MEMBERS OF BOSCH'S MIRR ORGANIZATION IN PUERTO RICO. MIAMI INFORMANTS HAVE PREVIOUSLY RECEIVED NO INFORMATION CONCERNING ANY INTENTION BY BOSCH TO BOMB SHIPS IN P.R. ALTHOUGH BOSCH IS DEFINITELY INVOLVED IN SHIP BOMBINGS, HE IS ALSO KNOWN TO TAKE CREDIT, WHERE POSSIBLE, FOR ACTS OF SABOTAGE BELIEVED NOT TO HAVE BEEN COMMITTED BY HIS ORGANIZATION.

MIAMI WILL MAINTAIN CLOSE CONTACT WITH ~~ANGULO~~ AND OTHER INFORMANTS TO OBTAIN ADDITIONAL INFORMATION.

NEW ORLEANS, MOBILE, HOUSTON AND TAMPA ADVISED SEPARATELY.
