MM [ONE TWO TWO EIGHT] - S (PROTECT) WHO HAS FURNISHED RELIABLE INFORMATION IN THE PAST, ADVISED THIS DATE WHILE IN THE DOGHOUSE RESTAURANT, MIAMI, AND SEATED NEXT TO ORLANDO BOSCH AND AN UNIDENTIFIED CUBAN MALE BELIEVED TO BE A CUBAN MEDICAL DOCTOR, SHE OVERHEARD THE FOLLOWING CONVERSATION WHICH WAS

CONDUCTED IN THE SPANISH LANGUAGE. BOSCH RELATED HIS CUBAN POWER GROUP WAS RESPONSIBLE FOR THE BOMBING OF THE SHIP IN SAN JUAN AND THE SHELLING OF THE POLANICA IN THE MIAMI HARBOR.

INFORMANT STATED BOSCH EXPLAINED HOW THEY USED A CAR TO TRANSPORT THE WEAPON ONTO THE CAUSEWAY TO THE APPROPRIATE SPOT FOR FIRING. HE ALSO INDICATED THE WEAPON WAS FIRED FROM OUTSIDE CAR AND CAR WAS THEN USED TO DEPART FROM THE AREA. INFORMANT
