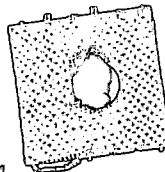
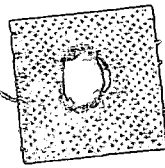

INS Headquarters, Washington, D.C., advised by liaison on 8/26/66 that subject was in possession of U.S. passport 1595958 and arrived in Montreal, Canada, on 8/25/66. Since his arrival in Canada he has received money from his wife in the U.S.

For the information of Ottawa, subject is on the Security Index due to his support of the Castro regime and expressed sympathy for the communist movement. He has been in Cuba since 1961 where he has been employed as a psychologist conducting psychological tests on Cuban children under sponsorship of the Castro regime. Information has been received that he was intending to return to the U.S. His wife, Lenna Schweitzer Jones, is on the Security Index and presently resides at 340 Haven Avenue, Apartment 5-S, New York City. Subject was born 3/17/34 in Arlington Heights, Ohio.

Ottawa through sources verify subject's arrival in Canada, determining if he came from Cuba and obtain any data re his intended destination in U.S. (C)

New York alert sources for subject's return to U.S. and his reunion with his wife in New York City. Ascertain his activities upon his arrival and submit recommendation re interview.
