GUS ALEX, AKA, AR. DAILY SUMMARY. PCI [REDACTED] ADVISED HE HAS RECEIVED A NUMBER OF COMPLAINTS FROM TENANTS OF THE APARTMENT BUILDING AT ELEVEN FIFTY NORTH LAKE SHORE DRIVE, CHICAGO, DURING THE PAST WEEK EXPRESSING CONCERN REGARDING GUS ALEX-S TENANCY AT THAT ADDRESS. HE SAID THESE COMPLAINTS WERE CAUSED BY A PICTURE STORY IN THE MAGAZINE SECTION OF THE CHICAGO TRIBUNE ON SUNDAY, OCT. EIGHT LAST, DEPICTING GRACIOUS LIVING ENJOYED BY CHICAGO QUOTE HOODLUMS UNQUOTE AND IT INCLUDED A PHOTOGRAPH OF THE APARTMENT BUILDING AND STATED THAT ALEX MAINTAINED A TENTH FLOOR SUITE AT THAT ADDRESS. PCI SAID THAT BECAUSE OF THE ABOVE COMPLAINTS AND THE RECENT PUBLICITY THE LEASE FOR ALEX-S APARTMENT WILL NOT BE RENEWED UPON TERMINATION. BUREAU AGENTS OBSERVED ALEX TOGETHER WITH HIS CHAUFFEUR BUTCH LADON AND EDDIE VOGEL AT MIKE FISH-S RESTAURANT, ONTARIO AND CHICAGO ON OCT. ELEVEN LAST. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
