GUS ALEX, AKA., AR. DAILY SUMMARY. CONCERNING INFORMATION PREVIOUSLY REPORTED THAT ONE GARY HARDIN FORMERLY EMPLOYED BY NEVADA EMPLOYMENT AGENCY IN LAS VEGAS MIGHT HAVE INFORMATION CONCERNING GUS ALEX, INVESTIGATION AT LAS VEGAS REVEALED GEORGE GARY HARDIN PRESENTLY RESIDING RIVERSIDE, CALIFORNIA. HARDIN INTERVIEWED OCTOBER TEN LAST AND DISCLAIMED ANY KNOWLEDGE CONCERNING ALEX OR HIS ACTIVITIES. HARDIN STATED, HOWEVER, HIS MOTHER, MRS. W. C. HARDIN, WHO NOW RESIDES AT MC MARY, ARIZONA, WAS EMPLOYED AS A NURSE BY LOS ANGELES HOODLUM JOSEPH STACHER FROM SEPTEMBER, NINETEEN FIFTYTHREE TO JULY, NINETEEN FIFTYFOUR DURING WHICH TIME STACHER RESIDED IN LAS VEGAS AND SHE MIGHT HAVE KNOWLEDGE REGARDING ALEX. CG SIX FOUR FOUR THREE DASH C HAS ADVISED THAT ALEX, LESLIE KRUSE AND JOHN DREW LAS VEGAS GAMBLING INSTRUCTED NOT TO CONTACT OR PERSONALLY ASSOCIATE WITH SIDNAY KORSHAK. INFORMANT STATED THE REASON FOR THIS IS PROBABLY TO KEEP KORSHAK FROM BEING TAINTED BY ASSOCIATION WITH QUOTE OUTFIT ENQUOTE PEOPLE. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
