GUS ALEX, AKA, AR. DAILY SUMMARY. RE BUREAU AIRTEL DATED DECEMBER 18, 1961 GRANTING AUTHORITY FOR ESTABLISHMENT OF MICROPHONE SURVEILLANCE ON SUBJECT'S APARTMENT. MICROPHONE SURVEILLANCE ESTABLISHED ON RESIDENCE OF GUS ALEX AT APARTMENT 10 C, 1150 NORTH LAKE SHORE DRIVE, CHICAGO, ILL., AS OF 7:45 P. M., JANUARY 4, 1962. MICROPHONE SURVEILLANCE HAS BEEN ASSIGNED SYMBOL NUMBER CG - 6502-C\* AND WILL BE MAINTAINED IN THE CHICAGO OFFICE CONSOLIDATED PLANT. PCI [REDACTED] ADVISED THAT SUBJECT APPARENTLY OUT OF TOWN DURING CHRISTMAS AND NEW YEAR HOLIDAYS AS HE HAS NOT OBSERVED HIM AT HIS RESIDENCE SINCE A FEW DAYS BEFORE CHRISTMAS LAST. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
