CG 6502-C* ADVISED ON MARCH 17, LAST, SUZANNE FUEGER, PARAMOUR OF ALEX, INQUIRED OF ALEX IF HE HAD SEEN MAE RECENTLY AND ALEX REPLIED IN THE NEGATIVE. MAE IS WIFE OF SUBJECT'S BROTHER, SAM ALEX. THEY ARE HANDLING THE REDECORATING OF ALEX'S APARTMENT WHICH IS SCHEDULED TO BEGIN THE EARLY PART OF APRIL. SUZANNE SAID SHE WOULD LIKE TO SEE MAE BEFORE THE CLEANERS ARRIVE AS SHE HAS SOME ADDITIONAL WORK SHE WANTED MAE TO HAVE THE CLEANERS DO. ALEX SAID THAT MAE AND SAM WOULD PROBABLY BE IN CHICAGO TO VISIT THEM PRIOR TO RE-DECORATING TIME.

PCI ADVISED THAT HE HAD THE PAINTERS SCHEDULED FOR REDECORATING AND PAINTING OF ALEX'S APARTMENT TO BEGIN ON APRIL 4, NEXT. HE STATED THAT HE WOULD ARRANGE TO NOTE THE NAMES OF THE OTHER BUSINESS FIRMS SCHEDULED TO DO CONTRACT WORK FOR ALEX DURING THE TIME THE APARTMENT IS REDECORATED AND WOULD FURNISH THESE NAMES TO THE CONTACTING AGENT WHEN HE RECEIVED THEM. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
