DAILY SUMMARY.

CG SIX FOUR FOUR THREE DASH C ADVISED HE HAS RECENTLY HEARD A DEVELOPMENT REGARDING NICK KOKENOS, OPERATOR OF NICKY/S LOUNGE, IN CICERO, ILLINOIS, REGARDING HIS RELATIONSHIP WITH ALEX. KOKENOS WAS QUOTE " ON THE OUTS WITH ALEX ENQUOTE. HOWEVER, SINCE THEIR DIFFERENCES HAVE BEEN SETTLED, ALEX NOW IS REQUIRING MINOR HOODLUNS TO ATTEND THE LOUNGE ON MONDAY, WEDNESDAY, AND FRIDAY, TO AID KOKENOS FINANCIALLY.
