GUS ALEX, AKA, AR. DAILY SUMMARY.

CG 6443-C ADVISED HE RECENTLY LEARNED THROUGH LOUIS TORNABENE THAT ALEX HAS BEEN COMPLAINING BITTERLY BECAUSE OF THE TERRIFIC "HEAT" ON THE STRIP JOINTS PARTICULARLY ON THE SOUTH SIDE OF CHICAGO. ALEX REPORTEDLY TOLD TORNABENE THAT HE STANDS TO LOSE \$120,000 PER YEAR AS RESULT OF THE CLOSING DOWN OF THE STRIP JOINTS. TORNABENE EXPLAINED THAT "THAT'S GUSIE'S END." TORNABENE EXPLAINED FURTHER THAT ALEX AND HIS ASSOCIATES ARE AT A LOSS AS HOW TO CIRCUMVENT CLOSING THE STRIP JOINTS AND SUBSEQUENT PUBLICITY. TORNABENE STATED CROSSROADS RESTAURANT WAS GOOD FOR \$45,000 NET PER MONTH WHILE RUNNING WIDE OPEN AND ALTHOUGH TONY TORNABENE IS A VERY CLOSE FRIEND OF CAPTAIN JAMES RIORDAN, FIRST DISTRICT, HE COMPLAINED BITTERLY THAT THOUGH RIORDAN WAS PAID OFF HE HAS REMAINED UNSCATHED AS RESULT OF HEAT AND IS NOW ONLY PERSON WHO REALLY MADE ANY MONEY OUT OF STRIP JOINTS IN PAST SEVERAL MONTHS. TORNABENE STATED "WOULD'T YOU KNOW THE LOUSY COPS MADE ALL THE MONEY."

AS A FURTHER END RESULT OF THE ABOVE MENTIONED CLOSINGS IT HAS RECENTLY BEEN REPORTED THAT LOUIS ARGER, ALEX'S LIEUTENANT, HAS SUFFERED A HEART ATTACK AND HAS BEEN HOSPITALIZED. ALSO AS A RESULT OF INFO FURNISHED BY CG 6443-C CONCERNING FHA VIOLATIONS ON PART OF LOUIS TORNABENE, STRIP JOINT OPERATOR AND LIEUTENANT OF ALEX, IT IS ANTICIPATED FHA MATTER TO BE PRESENTED TO FGJ, CHICAGO, SOON WHICH SHOULD FURTHER HAMPER GUS ALEX'S GROUP.
