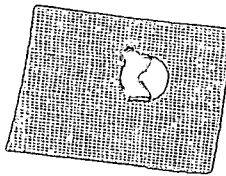
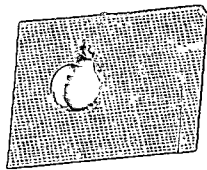

Through the cooperation and checking by the Southern Bell Telephone and Telegraph Company, New Orleans, La., it has been determined that the New Orleans Fair Grounds Race Track services is being disseminated to the New Orleans Hand-book operators through telephone number 947-6206 which is listed by the Southern Bell Telephone and Telegraph Company as being installed at 3021 1/2 Fortin Street. This phone was issued to MORRIS WILLIAMS, a truck driver for the M & M Laundry and Cleaners. Calls have been traced from this number to VERNON 4-2917 which telephone is listed as being installed at 336 Collidge Street, Jefferson Parish. This phone is listed in the name of E. GANES, SR. and Associates and is an unpublished business phone. Observation of the exposed telephone lines in the area of 3021 1/2 Fortin Street and 336 Collidge indicates that there are apparently a number of unauthorized extensions in both of these areas.

PCI NO1203PC who is well acquainted with the race track situation in New Orleans has advised that this service is provided by ABEL CHAUVIN, who is formerly connected with the Nola Printing Company, LAMBERT MITCHEL and ZEEK DOMING. NO1203PC advised that MITCHEL and DOMING handled the race track service in New Orleans during the latter part of 1961 - 1962 season.

NO1203PC advised that another service is being operated from the corner of Sauvage Road and Fortin Street. Informant had not been able to determine who is handling the service from this address, however states things service being provided by SAM SAIA. The telephone lines running to this residence were observed and there appears at least two unauthorized telephones running to this address.

Efforts are currently being made to determine if this service is being transmitted outside of the State of Louisiana.

Contact has been maintained with FRED SOULE, Commanding Officer of the New Orleans Police Department Vice Squad, who has confirmed at the present time the New Orleans Police Department has several individuals operating in an undercover capacity for attempting to penetrate local handbook operation and place bets with these operators. He admitted that they had been successful in a number of instances but they have not effected arrest because they are desiring to develop additional violations and that they do not at this time wish to expose their undercover operators. He advised he anticipates it will be several weeks before charges will be filed on the cases that have already been made.

SOULE advised that to date there has been no indication that any service provided by local books is being relayed out of the State. Investigation is continuing to determine the extent of the race wire service in this area.
