CG SIX SIX ONE FOUR - C ADVISED THAT GUS ALEX, RALPH
PIERCE AND LESLIE KRUSE MET DEC EIGHT INSTANT AT LOCATION
HERETOFORE UNKNOWN TO CHICAGO OFFICE AS MEETING PLACE.
CI STATED THAT PIERCE, WHO HAS PURCHASED NEW CADILLAC
CONVERTIBLE, AND APPEARS TO BE IN CONTINUED ILL HEALTH,
WAS JOINED AT BOVERI'S ITALIAN RESTAURANT, TWENTY EAST LAKE
STREET, CHICAGO, BY KRUSE AND THEN ALEX.

NOTED IN SUMMER NINETEEN SIXTY FIVE, HUMPHREYS GROUP
DISCUSSED CHANGING LOCATION OF MEETING PLACES FOR SECURITY
PURPOSES. AT TIME HY GODFREY SUGGESTED GROUP BEGIN
HOLDING MEETINGS AT "THAT ITALIAN RESTAURANT ON LAKE STREET"
WHICH HE SAID GROUP HAD NOT MET AT FOR TWO YEARS
CHICAGO OFFICE HERETOFORE UNABLE TO DEFINITELY IDENTIFY LOCATION
THIS ESTABLISHMENT. HOWEVER, NOW APPEARS BOVERI'S IS PLACE
MENTIONED BY GODFREY.
