NOTED ABOVE INFO EXPLAINS OBSERVATIONS OF CG SIX SIX ONE FOUR - C JAN TWENTY THREE RE MEET OF ALEX, PIERCE AND KRUSE WITH HARRY BUSCH AND OF ALEX WITH BRODKIN AND <sup>N</sup>CONFIRMS INTERPRETATION OF CHICAGO DIVISION RE THOSE MEETINGS. ALSO CONFIRMS INFO SUPPLIED IN PAST THAT ALEX IS IN CHARGE OF CONTACTS CHICAGO HOODLUM GROUP WITH LABOR UNION LEADERS AND THAT BIEBER AND BRODKIN OBTAINED JURY PANEL REGULARLY FOR USE OF HUMPHREYS GROUP INCLUDING ALEX, PIERCE AND KRUSE, TO BE USED TO DETERMINE FEASIBILITY OF CONTACT OF MEMBERS OF PANEL INCLUDING THOSE WHO ARE UNION MEMBERS BY THEIR LEADERS.
