6. Type of case involved:

CRIMINAL INTELLIGENCE PROGRAM - AR

7. Connection or status of subject in the case:

SAMUEL M. GIANCANA, Top Hoodlum, Chicago Area, has been residing in house at Green Gables Ranch with PHYLLIS MC GUIRE. Several unknown individuals have visited subject at ranch during his stay there. (U)

8. Specific information being sought:

General intelligence information concerning GIANCANA and other Chicago Hoodlums as well as Las Vegas Hoodlums who might visit GIANCANA at ranch. Also possibly specific information relative to hidden interest in gambling casinos in Las Vegas. (U)

9. Reasons for believing the specific information will be obtained by the technical surveillance:

GIANCANA stayed in house 24 hours a day until he departed for Chicago on July 5th. Highly confidential source advised numerous items of his clothing are still in house, therefore, it is felt he may return to Las Vegas. It is believed he will probably discuss business with visitors and PHYLLIS MC GUIRE. (U)

10. Importance of case and subject:

SAMUEL M. GIANCANA is a very important Top Hoodlum in Chicago. He is one whom the Bureau has selected for intensification. (U)
