TO ENRIQUE SOMELLAN, TWO NINE ONE SEVEN SIXTEENTH STREET,  
TAMPA, WHO IS TP FIFTY TWO S.

TODAY TP FIFTY TWO S ADVISED AS FOLLOWS: (4)(u)

HE IS LOCAL HEAD OF MOVIMIENTO INSURRECIONAL DE  
RECUPERACION REVOLUTIONARIA (MIRR) IN TAMPA, FLORIDA, AND  
NATURALLY FRIENDS WITH ORLANDO BOSCH OF MIRR IN MIAMI, FLORIDA.  
BOSCH OFTEN CALLS FROM MIAMI BUT USUALLY REVERSES THE TOLL CHARGES  
TO TAMPA. TP FIFTY TWO S SHOWED TOLL CALL RECORD FOR AUGUST SIXTY  
EIGHT WHICH REFLECTED CALL TO MIAMI AUGUST FIFTEEN INSTANT, AND  
TP FIFTY TWO S STATED HE THOUGHT THIS CALL WAS FROM BOSCH,  
AND THAT HE RECALLED NO CALL FROM BOSCH ON AUGUST FIVE INSTANT.
