ON NIGHT OCT. TWENTYFOUR LAST, OSCAR ANGULO REYES, PSI  
UNDER DEVELOPMENT, WHO HAS FURNISHED RELIABLE INFORMATION  
PREVIOUSLY IN THIS CASE, REPORTED THAT MARCELINO GARCIA JIMENEZ  
AND JORGE GUTIERREZ ULLA, CO-DEFENDANT, AND BOTH MEMBERS BOSCH'S  
CUBAN POWER, WERE INVOLVED IN DISCUSSION NIGHT OF OCT. TWENTY-  
THREE. GARCIA STATED THAT IT IS IMPORTANT TO RAISE BOND MONEY  
TO OBTAIN RELEASE FROM JAIL OF ANDRES JORGE GONZALEZ GONZALEZ,
