THERE ARE A CARETAKER AND OTHER HELP PERMANENTLY IN RESIDENCE AND IN CONTACT WITH JORGE CASTILLO, A LEADING MEXICAN ATTORNEY ~~[REDACTED]~~

NOTED THAT EVEN ON APPREHENSION IMMIGRATION AGENTS DID NOT ENTER PREMISES BUT LURED GIANCANA TO THE ENTRY AREA BY CLAIMING INTEREST IN PURCHASING THE HOUSE. REPORTEDLY GIANCANA NORMALLY WOULD SEE NO ONE BUT WAS INTRIGUED BY THE FACT THAT THE VISITOR CLAIMED HE WOULD MAKE AN OFFER THAT COULD NOT BE REFUSED. ~~[REDACTED]~~

CONSIDERED THAT SUBJECT'S ATTORNEY CASTILLO WILL BE IN POSITION TO OPPOSE ANY EFFORTS TO OBTAIN ACCESS TO SUBJECT'S DOCUMENTS OR EFFECTS. SUBJECT TOLD MEXICAN IMMIGRATION INSPECTORS HE WOULD NOT BE RETURNING TO MEXICO AND WAS TOLD BY IMMIGRATION THAT HE WOULD BE PROSECUTED SHOULD HE RETURN. PRESUMABLY CASTILLO WILL FORWARD HIS EFFECTS AND MEXICO CITY WILL ATTEMPT TO OBTAIN INFORMATION AS TO ANY SUCH FORWARDING FROM SOURCES OR FROM MEXICAN IMMIGRATION.
