LEBANON. A NUMBER OF COMMUNICATIONS FROM THIS OFFICE HAVE REPORTED RUMORS AMONG SUBJECT'S ASSOCIATES IN MEXICO THAT HE WAS SPENDING SOME TIME IN LEBANON. MEXICO CITY LETTER, JANUARY 18, 1973, REPORTED THAT SUBJECT'S ATTORNEY SHOWED A MEXICAN IMMIGRATION OFFICIAL A POST CARD RECEIVED FROM SUBJECT FROM BEIRUT, LEBANON, APPARENTLY TO INDICATE THAT SUBJECT WAS NOT IN MEXICO AT THAT TIME. CONFIRMATION OF SUBJECT'S OCCASIONAL PRESENCE IN LEBANON ALSO CONTAINED IN CHICAGO AIRTEL, JANUARY 18, 1974, AND LETTERS FROM LEGAT, BEIRUT, DATED JULY 12 AND JULY 18, 1974. *S(F)u*

PANAMA. MEXICO CITY AIRTEL AND LHM, APRIL 13, 1967, REPORTED DETAILS FROM MEXICAN IMMIGRATION THAT SUBJECT LEFT MEXICO ON SEPTEMBER 10, 1966, DESTINED FRO PANAMA ON VARIG AIRLINES FLIGHT 811. *(w)* MEXICO CITY AIRTEL MAY 17, 1967, CARRIED VERIFICATION OF SUBJECT'S ARRIVAL IN PANAMA CITY, PANAMA, ON THE ABOVE DATE. ~~ON~~ ON THE SAME FLIGHT WAS SUBJECT'S ASSOCIATE, LISTED AS RICHARD SCALZITTI CAIN *JCP*
