FOR YOUR INFORMATION, GIANCANA WAS FORCED TO LEAVE MEXICO BY MEXICAN AUTHORITIES IN JULY, 1974, AND IS PRESENTLY IN CHICAGO, ILLINOIS, AWAITING RETURN BEFORE FEDERAL GRAND JURY LOOKING INTO HIS CONNECTIONS WITH ORGANIZED CRIME DURING THE PERIOD OF 1966 TO THE PRESENT. ~~KA~~ HIGHLY SENSITIVE SOURCE AVAILABLE TO LEGAT, MEXICO CITY, HAS DETERMINED A TELEPHONE CALL WAS MADE FROM GIANCANA'S MEXICAN RESIDENCE ON JULY 17, 1974, TO LEBANON NUMBER 981-088, ONE DAY BEFORE HE WAS EVICTED FROM THE COUNTRY.
