MEX 170 on 12/16/74 furnished the following information concerning Mexico City telephone numbers: (S)(u)

535-7859 - Eastern Airlines Reservations Office;

566-6236 - Collections Department for Excelsior, a leading Mexico City Spanish language daily newspaper.

These are the top and bottom items of Page 2, memo enclosed by Mexico City airtel 11/4/74, and completes the identification of telephones in Mexico called from subject's residence in Cuernavaca, Mexico. (S)(u)

MEX 156 and MEX 170 continue efforts to determine significance of some of these individuals as related to the subject. MEX 156 advised 11/26/74 that Colorines 116, (item ten, Mexico City insert to airtel 10/31/74) is a single family residence in the Pedregal section of Mexico City (where subject was once reported to have a home). It apparently is unoccupied and neighbors consider it has been vacant for some time and knew nothing about the house's previous occupants. (S)(u)
