ADVISED SEPTEMBER 7 CONTACT WAS HAD WITH JIMMY LONGO AUGUST 28 WHO TOLD HIM SUBJECT WAS AT HIS TAMPA RESIDENCE. ON AUGUST 29^t SOURCE CONTACTED SUBJECT AT HIS RESIDENCE AND WENT TO CENTRAL BANK OF TAMPA WHERE AN ASSOCIATION OF TP 41 PCI GOT LOAN. UPON COMING OUT OF BANK, SUBJECT POINTED OUT BLUE LATE MODEL STATION WAGON TO SURCE, STATING FBI WAS CONTINUING TO SURVEIL HIM. SOURCE SAID SUBJECT RETURNED THEN TO RESIDENCE AND STATION WAGON SEEN NEAR RESIDENCE. ON SAME DATE SUBJECT ALLEGEDLY RELATED HE WAS LEAVING FOR MAIMI. SOURCE WILL AGAIN GO TO MAIMI IN NEAR FUTURE.
