TP T-5 advised SAs O'BRIEN and LABADIE on October 20, 1961 that he was advised by AUGUST C. PANIELLO during the early morning hours of October 20, 1961 that subject was in Miami, Florida and that subject did not intend to return to Tampa. Source said PANIELO related that his mother-in-law, Mrs. SANTO TRAFFICANTE, returned to Tampa along by plane from Miami on Sunday, October 15, 1961. Source intended to make a trip to Miami in the near future.

RE: CUBAN RANCH NEAR AVON PARK, FLORIDA

The following investigation was conducted by SA GLYDE B. GENTRY, JR. at Sebring, Florida:

Deputy Sheriff GEORGE CRIST, Highlands County Sheriff's Office, Sebring, Florida advised October 17, 1961, there is no ranch in Avon Park, Florida owned by Cubans. He stated the only ranches owned by Cubans in Highlands County are the FERNANDEZ family and the FALLA family. The FERNANDEZ family own the Sante Fe Ranch, Incorporated, located on the Lorida Road, Northeast of Sebring. The FALLA family own a small ranch next to the FERNANDEZ family which was the old GEORGE CROSS property. CRIST stated he rents his house to the FALLA family in Sebring and the FALLA family have no houses or other buildings on the ranch. The FERNANDEZ family have three houses and a house trailer on their property. CRIST viewed a photograph of SANTO TRAFFICANTE, FRANK DIECIDUE, and AUGUST PRIMO LAZARA and advised he has not seen these individuals in the Sebring area.

TP T-6 advised October 17, 1961, she is a neighbor of the FERNANDEZ family consisting of the father, REMAGIO FERNANDEZ, age 70; mother, MARIA FERNANDEZ nee QUIRCH, age 65; son, VICTOR FERNANDEZ, age 31; SERGIO (SAMUEL) FERNANDEZ, age 25; son, QUILLERMO (WILLIAM) FERNANDEZ, age 23; and ALBERTO FERNANDEZ, age 28. She stated she has seen no recent visitors at the FERNANDEZ fanch which is known as the Sante Fe Ranch. She viewed a photograph of SANTO TRAFFICANTE, FRANK DIECIDUE and AUGUSTINE PRIMO LAZARA and advised she has not seen anyone at the ranch or in Sebring resembling the photographs of these individuals.
