On 9/14/61, information relating to NORBERTO FUENTES GARCIA was furnished to Attorney SANTIAGO IBANEZ LLAMAS, Director of the Inspection Department of the Mexican Immigration Service, in view of the possibility that FUENTES was gainfully employed in Mexico on an illegal basis.

On 10/25/61, Inspector FLORENCIO VIVAS advised that FUENTES GARCIA's case had been assigned to him and that he had been unable to locate FUENTES GARCIA in Mexico. He stated that a neighborhood inquiry at Calle San Juan de Letran #13, Office 1601, had developed information that FUENTES GARCIA "no longer was connected with its office." VIVAS stated that he is continuing his efforts to locate FUENTES GARCIA but believes he may have returned to Havana, Cuba.
