FBI AGENT THAT HE DID NOT DESIRE TO SERVE MORE PRISON TIME AND ALSO INDICATED HE WOULD FURNISH ADDITIONAL INFORMATION CONCERNING MARCELLOS GUATEMALAN CITIZENSHIP IF SOME AGENCY COULD QUOTE MAKE HIM A DEAL UNQUOTE. BY LETTER OF FEB. NINE, SIXTY, BUREAU FORWARDED TO NEW ORLEANS REPORTS OF INTERVIEW OF NOLL BY INS WHICH INTERVIEW TOOK PLACE JAN. SIX AND SEVEN , SIXTY AT USP, LEWISBURG THIS MATERIAL REFLECTS THAT NOLL GAVE INS INVESTIGATORS DETAILS CONCERNING HOW HE ARRANGED TO HAVE MARCELLOS NAME ENTERED INTO BIRTH RECORDS OF SOME VILLAGE NORTH OF GUATEMALA CITY IN ABOUT NINETEEN FIFTY SIX.
