On 10/7/59, Mr. [redacted], Treasurer, Rand Development Corp., contacted Cleveland Office and advised that they had been in telephonic contact with U.S. Embassy, Moscow, USSR, on this date. Embassy advised them they had received letter from subject stating he wished to remain in Russia and not return to the United States. Subject supposedly working in Leningrad, USSR.

OTHER 4

[redacted] stated JAMES H. RAND leaving for Moscow Friday, 10/9/59, where he will look into the matter concerning subject. RAND will telephonically contact [redacted] approximately middle of week following 10/9/59 and give him full details concerning WEBSTER at that time. [redacted] stated he will advise the Cleveland Division immediately upon receipt of information from RAND.

Re Cleveland airtel requested permission to interview subject on his return to the United States. This request is reiterated herewith in the event subject further changes his mind and does return to the United States in the near future. If information is received indicating subject will remain in the USSR for an additional extended period, Cleveland will make appropriate recommendations at that time.
