Re Bureau letter to Washington Field, 7/12/62.

Enclosed for the Bureau are five copies of a letterhead memorandum concerning contact with ROBERT EDWARD WEBSTER, 311 East Beaver St., Zellenople, Pa., (S)(U) re IVAN ALEXANDROVITCH SHISHKIN and his wife, ZINAIDA SHISHKIN. A copy of the letterhead memorandum is also enclosed for Washington Field. (S)(U)

A copy of this letter has been furnished to Cleveland as WEBSTER's ex-wife presently resides within Cleveland territory. (S)(U)

The enclosed memorandum has been classified "Secret" since it concerns a highly sensitive investigation involving CIA personnel abroad. (S)(U)

MRS. ROBERT EDWARD WEBSTER advised that during the period 7/15-28/62 he was in Washington, D.C., being interviewed by CIA and that he will have periodic contact with CIA representatives in Pittsburgh. WEBSTER stated that CIA personnel in Washington told him that they were pleased with the results of these interviews and appreciated his cooperation. WEBSTER stated that he was afforded an IQ test and received "some psychiatric help" from CIA while in Washington. (S)(U)

MRS. MRS. WEBSTER advised that his ex-wife, MARTHA, re-married on 7/21/62. Her husband is WILLIAM G. BELDING, who is the publisher or an executive of a newspaper (name unknown) at Hubbard, Ohio. She will reside with her two children at 50 Washington St., Niles, Ohio. (S)(U)

On July 31, 1962, photographs of Ivan Alexandrovitch Shishkin and his wife, Zinaida Shishkin, were displayed to Robert Edward Webster, 311 East Beaver St., Zellenople, Pa., who renounced his United States citizenship and resided at Leningrad, Russia, from 1959 to May, 1962. Webster advised that the Shishkins were unknown to him; that he had not met them in Russia; and that he could furnish no information concerning them. (S) (U)

It is noted that in May, 1962, Webster advised Special Agents of the Federal Bureau of Investigation that he was in contact with one Alexander Shishkin at the American National Exhibition in Moscow in 1959. On July 31, 1962 Webster stated that he had been mistaken concerning the name of this individual and that he should have identified him as Michael Shishkin. According to Webster, Michael Shishkin is not identical with Ivan Alexandrovitch Shishkin.
