

them in Russia; and that he could furnish no
information concerning them.

It is noted that in May, 1962, Webster advised Special Agents of the Federal Bureau of Investigation that he was in contact with one Alexander Shishkin at the American National Exhibition in Moscow in 1959. On July 31, 1962 Webster stated that he had been mistaken concerning the name of this individual and that he should have identified him as Michael Shishkin According to Webster, Michael (5) Shishkin is not identical with Ivan Alexandrovitch Shishkin 16
