On 7/22/68, the San Francisco Office advised that a review of the San Francisco Police Department records revealed that there was no record of any outstanding warrant or detainers being held at that time for JOHN CEASAR GROSSI. Investigation reflected that the San Francisco Police Department had cancelled their previously issued warrants against GROSSI and the detainer had been removed.

On 8/26/68, the Dallas Office advised that Chief Deputy ALLAN SWEATT, Dallas County Sheriff's Office, stated that his office was still desirous of returning JOHN CEASAR GROSSI to Dallas and that a detainer was still pending against GROSSI at the Kingston Penitentiary, Kingston, Ontario, and that they were again sending a letter to the Kingston Penitentiary confirming this detainer.

On 8/30/68, the Buffalo Office furnished background information regarding MICHAEL CARL TASCARELLA relating to his activities since 1953 within the Buffalo Division. This information was furnished to the Albany Office in the event GROSSI was to be interviewed.

On 10/29/68, Associate Deputy Warden W. CHINNERY, Kingston Penitentiary, Kingston, Ontario, advised that JOHN CEASAR GROSSI was originally scheduled to be released on 10/31/68; however, the Board had suled that he did not submit his application soon enough and it did not appear that he would be released before January, 1969. he was released. He said that this upset GROSSI and he did not appear to be in any helpful mood.

Mr. CHINNERY stated he would make inquiry of GROSSI to determine if he was still desirous of being interviewed by an Agent and in the event he was, Mr. CHINNERY would advise the FBI at Watertown, N. Y.

On 11/1/68, Deputy W. CHINNERY, Kingston, Ontario Penitentiary, advised that JOHN CEASAR GROSSI stated that he did not desire at this time to be reinterviewed and inasmuch as he was being released soon to the Dallas, Texas, authorities, in the event he had any additional contact with the FBI, he would contact the FBI at Dallas, Texas.

On 12/5/68, Deputy CHINNERY, Kingston, Ontario, Penitentiary, advised that JOHN CEASAR GROSSI had been granted a full pardon on 12/13/68, and was reportedly taken to Toronto, Ontario, to be deported. He stated that on 11/18/68, a letter was received from JOHN CEASAR GROSSI stating that all charges in the states had been dropped against him and that he was on his way to San Francisco, California, where he was obtaining employment.

Inasmuch as GROSSI did not desire to be reinterviewed by the FBI and he has been released from the Kingston, Ontario, Penitentiary, no further investigation is being conducted in this matter and this case is being considered closed.

On 6/12/68; Associate Deputy Warden, W. CHINNERY, Kingston Penitentiary, Kingston, Ontario, telephonically contacted SA J. ROBERT HOWARD, and advised that one JOHN CAESAR GROSSI, presently incarcerated in the penitentiary for bank robbery desired to speak to an FBI Agent.

On 6/14/68, CHIMNERY advised that GROSSI, who is present working in the penitentiary hospital, desired to speak to an Agent. He stated that GROSSI is a very sophisticated type of immate, who is eligible for parole October 31, 1968.

On 6/14/68, JOHN CAESAR GROSSI, presently in Kingston Penitentiary, advised that he has two detainers filed against him. one from Dalls, Texas, for theft by false pretenses, and one from San Francisco, California, for auto theft. GROSSI stated that he will be eligible for parole October 31, 1968, and does not desire to return to either state for further incarceration.

GROSSI said that over the years, he has become acquainto with members of the underworld and served time at the Federal Penitentiary with FRANK COSTELLO, VITO GENOVESSE, and JOE DJV PALERMO

GROSSI further advised that he was also quite well acquainted with one SAMDIBELIA, New York City, who he believes the FBI contacted when he, DROSSI, was being sought as a fugitive. He stated that DIBELIA has a brother JOE, who runs a cleaning and

dye establishment in Long Island, N.Y., and both the DIBELIAs are connected with the underworld in the New York City area.

GROSSI stated that at the present time he is working in the prison hospital with one MIKE TASCARELIA, from Buffalo, W.Y., presently serving a 14 year sentence for narcotics. He advised that he believes that he has acquired the confidence of TASCARELIA, who has informed him, GROSSI, that when he is released, he would see that GROSSI gets an introduction to one FRANK (SILVESTRO (phonetic), from Hamilton, Ontario, Canada, who reportedly is a big man in marcotics and gambling.

charges against him are dismissed, to make contact with SILVESTRO and SAM DIBELIA, in an effort to gain their confidence, and is willing to assist the FBI in obtaining information regarding these persons. He related that heis willing to stick his neck on a meat block if necessary. GROSSI said that there are other people he is acquainted with but did not believe in giving away any free samples without something in return. GROSSI was informed that the FBI could not make any promises or offers to get the charges dropped and would possibly contact him at a later date. GROSSI said that if any additional contacts are to be made, the arrangements should be made with Deputy Warden CHIMMERY.

It is noted that GROSSI is identical with JAMES CAESAR KGROSSI, former I.O. number 3906, Bureau file 88-30913.
