The confidential source of information mentioned in the LHM is Lt. RAFAEL ALVAREZ JIMENEZ, Police of Puerto Rico, Hato Rey, P.R., who obtained the information from an informant using the code name, "ACE", and which information was furnished to SJO on 3/12/64, in the form of a written report in the Spanish language.
