The files also indicates that in 1932 SANCHEZ joined the Communist Party of New York, and in 1932 attended a Labor Defense Congress in Moscow, Russia. The file indicated that on September 24, 1934, ALBERTO E. SANCHEZ became General Secretary of the Partido Communisto Puertorriqueno (Communist Party of Puerto Rico) (PCP). On May 29, 1941, he admitted to Agents of the SJO of the FBI that he was President of the Communist Party of Puerto Rico and that he felt no loyalty to the United States, believing in the independence

of Puerto Rico and stated he was loyal only to Puerto Rico.

As of July 24, 1943, SANCHEZ was a member of the Executive Committee of the PCP and was that party's candidate for Resident Commissioner in Washington, D. C. As of May 21, 1944, he was a member of the Central Committee of the PCP.

In March, 1949, SANCHEZ was expelled from the PCP.

(PCP is a communist party in its own right and not a district organization of the Communist Party, USA, although it is based on the same Marxist-Leninist principles.)

(The Communist Party, USA has been cited by the Attorney General of the United States as an organization within the purview of Executive Order 9835.)

This individual in 1947 became a member of This individual continued active in this organization and in the "Diario de Puerto Rico, " a Spanish language daily newspaper formerly published in San Juan, Puerto Rico, in a statementin its February 14, 1951 issue stated as follows:

"LEONARDO S. SCHLAFER, warehouse guard at the Office of Collections, Treasury Department, was discharged from his position by SOL LUIS DESCARTES. Treasurer of Puerto Rico, because of affiliation with the PCP. He was discharged on February 5, 1951, and he filed an appeal before the personnel board on February 8, 1951, although a date for the hearing on the appeal has not yet been set. According to the letter sent to SCHLAFER by Treasury Director, he was discharging the accused 'while you were duties of warehouse guard in the Office of Collections, Department of Treasury, you were a member of the PCP, an organization which advocates the overthrow of the United States andeof Puerto Rico by force and violence, and to which organization you rendered aid and support.

On August 26, 1955, the Personnel Board of the Commonwealth of Puerto Rico confirmed an order of dismissal issued February 5, 1951, by the Treasury of Puerto Rico against LEONARD S. SCHLAFER. A portion of the article set forth the opinion of the board which was published in the August 30, 1955, issue of the "El Mundo", a Spanish language newspaper published daily in San Juan, Puerto Rico. A English translation of a portion of this statement is set forth below:

"In our opinion a person who admits that he sympathizes with Soviet Russia and with the Communist Party; who participates as orator in communist matters, attends communist rallys and participates in the distribution of leaflets at the same; who visits the offices of the communist party and chats with communist leaders; who endeavors to secure subscribers for Soviet propaganda magazines; and who performs the rest of the activities which the appellant in this case performed, clearly should be pointed out and numbered as an affiliate of the communist party or member of the same."

This article indicates that the assembly was held in Ponce, Puerto Rico, on November 22, 1959, and was attended by 1,300 delegates representing various pro independence groups on the fisland as well as the PCP. During the meeting LEONARD S. SCHLAFER was one of 50 delegates appointed to meet in the near future to form a directorate for the MPIPR as well as the elect 15 secretaries which would comprise the MPIPR leadership.

"Claridad," year one, issued 12, a self-described official organ of the MPIPR, contained an article regarding Constituent Convention of the MPIPR held in Ponce, Puerto Rico, on November 22, 1959. According to the article LEONARD® S. SCHLAFER is one of a group of individual elected MPIPR secretariat.

"Carta Semenal," number 85, dated December 22, 1962, contained a listing of 90 individuals who were elected to the National Council of the MPIPR at the Fourth General Assembly in Bayamon, Puerto Rico, on December 9, 1962. LEONARDO S. SCHLAFER was one of those listed as being elected to the National Council of the MPIPR.

The December 31, 1963, edition of "Carta Semenal," the self-described weekly news letter of the MPIPR to its missions, reported that LEONARDO S. SCHLAFER was elected to the 90 member National Council of the MPIPR at that organization's Fifth Annual General Assembly held in Ponce, Puerto Rico, on December 1, 1963.

Files of the SJO indicate that HERMANN STUBBE was born April 14, 1918, San Juan, Puerto Rico, graduated from the Northwestern University, Evanston, Illinois, in 1940. 1943, he was interviewed by a Special Agents of the FBI and advised that in June, 1935, he made a trip to Germany as a member of a group of young men of German background, which trip was sponsored by the German Government.

He stated that he traveled from San Juan to Santo Domingo and from there to Puerto Plata where the group boarded a ship belonging to the Horn Line. He stated that upon embarking the group was placed under

supervision of the Chief Steward, who was probably head of the Nazi organization for the ship and who wore the official National Socialist Party button on several occasions. During the voyage the group learned the Hitler salute and the official party songs. Upon arrival in Hamburg, Germany, the group was met by a committee made up of several groups of Hitler Youth and were taken to a camp approximately 20 miles west of Berlin, where there were approximately 2,500 boys from various countries throughout the world.

STUBBE advised that upon arrival at the camp, he and his companions were issued regulation Hitler Youth uniforms, but that in accepting the wearing of this uniform, neither he nor the others of the group were required to take any oath or vows of membership in the Hitler Youth organization. The camp was highly organized and the individuals were frequently called together for the purpose of listening to lectures and viewing propaganda films. Some of the speakers to the group included RUDOLF HESS, Doctor PAUL GOEBBLES and BALDUR VON SCHIRACH, party head of the Hitler Youth. Following the breaking up of the camp, a tour was taken of various cities in Germany, after which STUBBE returned to San Juan.

When questioned concerningibles or his family's political activity in Puerto Rico, STUBBE stated that he had never at any time had any relations with members of the Nazi Party in Puerto Rico or was active in pro-German affairs.

STUBBE stated that shortly after his return in 1935 to San Juan, he was contacted by the German Consul who requested that he appear at a local radio station and give an account of his experiences in Germany. STUBBE stated he agreed and was furnished a script. He stated he read the script over the radio, but that it did not last for more than approximately two minutes. He stated he gave the speech inasmuch as he had accepted the hospitality of the German Government.
