ON NIGHT OF JUNE 8 LAST PH 672-C-TE EQUIPPED WITH PORTABLE RECORDER VISITED RESIDENCE OF ANTONIO DOMINIC POLLINA, FORMER BOSS OF PHILA. FAMILY, LA COSA NOSTRA. RECORDED CONVERSATION ESTABLISHES WITHOUT A DOUBT INFORMANT IS MEMBER LA COSA NOSTRA. CONVERSATION CONCERNED PRESSURE OF FBI INTERVIEWS WITH POLLINA AND PRESSURE FROM FBI INVESTIGATIONS. INFORMANT ASKED POLLINA IF HE WOULD ACCEPT POSITION OF CAPODECINA IF IT WAS OFFERED HIM AND HE SAID HE POSITIVELY WOULD NOT. POLLINA COMPLAINED PHILIP TESTA AND JOHN CAPPELLO NEVER VISIT HIM AND THAT HE BELIEVES HE IS NO LONGER CONSIDERED MEMBER OF LA COSA NOSTRA. POLLINA STATED HE MADE ANGELO BRUNO CAPODECINA. FURTHER DETAILS WILL FOLLOW UPON TRANSLATION OF SICILIAN CONVERSATION.

Interstate Transportation in Aid of Racketeering

DURING BRUNO ITAR TRIAL TODAY, DEFENSE MADE TWO MOTIONS FOR CONTINUANCE ON BEHALF OF BRUNO AND JOSEPH STASSI BASED ON UNFAVORABLE PUBLICITY APPEARING IN PHILADELPHIA DAILY NEWS THIS DATE. BOTH MOTIONS DENIED. SEVEN JURORS HAVE BEEN SELECTED.

BRUNO CONSIDERED DANGEROUS.
