IN BRUNO ITAR CASE SOURCE ADVISED BRUNO AND HIS ATTORNEY THOMAS MC BRIDE ARE CONSIDERING POSSIBILITY OF HAVING BRUNO TAKE WITNESS STAND ON OWN BEHALF IN ORDER TO CREATE IMPRESSION IN JURY'S MIND HE IS BUSINESSMAN RATHER THAN TYPICAL RACKET FIGURE. BRUNO TOLD MC BRIDE HE WILL TAKE STAND IF MC BRIDE DESIRES IT. NO DECISION MADE ON THIS POINT.

PETER MAGGIO, BRUNO'S BROTHER IN LAW AND MEMBER COSA NOSTRA, OCCUPIED DURING DAY WITH DOMESTIC PROBLEM. SON FAILED HIS EIGHTH GRADE OF GRAMMER SCHOOL FOR SECOND YEAR IN ROW, RETURNED HOME AND DROVE OFF IN HIS CORVETTE WITHOUT SAYING WHERE HE WAS GOING.
