Authority is not granted for Newark to contact William Blanchard concerning instant matter in view of fact that such contact might result in exposure of NK 2319-C* as the original informant.

Since minutes of Teamsters Union Pension Fund, Chicago, do not contain any indication that a loan application on behalf of St. Barnabas Hospital has been made, NY 3936-C has stated he has no knowledge of proposed loan to this institution, NK 2319-C* has furnished no further significant information concerning this proposed loan and periodic observation of the construction at the hospital by Newark indicates very little progress has been made thereon in recent months, it is felt that this case should be placed in closed status subject to being reopened should additional information be received warranting such action.

All offices should remain alert to this matter and immediately advise the Bureau and Newark should any further information concerning same be received.
