For the information of the Bureau, NY has received no information which would in any way indicate that subject has renewed or attempted to renew his contacts with former NY [2620]S [ROBERT A. CURRY] since returning to the US from (S) home leave.] During the last interview with [CURRY] he (S) stated that he would notify the FBI in the event that [MISHUKOV] contacted him. To date, he apparently has not been contacted.

NY has closed 105 cases on DUSHKA HOWARTH, AMERICO SALEBE and PAUL WONNACOTT. None of the three are considered to be security risks and are not deemed to have any current potential as informants and/or double agents (6)

With respect to subject's past association with NY 2744-S, attention is called to the fact that on 9/15/60, and 9/30/60, this informant reported that he had not heard from (MISHUKOV) in several months. It is noted that (MISHUKOV) returned to the US from home leave on 9/14/60. He had (S) previously told NY(2744-S that he would get in touch with him when he (MISHUKOV) returned from home leave in the (S) soviet Union. NY plans to continue its efforts to direct NY 2744-S' activities against the subject. It is in the process of formulating a situation for the informant to initiate a contact with MISHUKOV.

In connection with the subject's attendance at the 10/14/60 party, attention is called to the fact that NY does not plan at this time to open a case on ALEXANDER KUTILIN. KUTILIN advised that he doubted if either MISHUKOV or BUKATIY were interested in him. He sparently based this belief on the fact that they did not solicit his address and telephone number during the party and further on the fact that they are well aware of his anti-Communist, anti-Soviet feelings.

KUTILIN stated that if he should learn anything further with respect to the Soviets association with (S) NATALIE KISSEIEFF, he would immediately contact the NYO. He further advised that should he be contacted by these or any other Soviets he would notify the FBI.

NY has opened a 105 contact case on NATALIE KISSELEFF and is in the process of conducting a background investigation. Upon the completion of this investigation, consideration will be given to requesting permission to interview her. It is noted that KUTILIN advised that he felt that Miss KISSELEFF was very naive in her association with the Soviets but that he believes she is anti-Communist in her feelings.

MISHUKOV first arrived in the United States on 11/20/57 (5) and his wife on 8/15/58; they departed this country on (5) home leave on 6/1/60. (but returned on 9/14/60. They [5] currently reside at [132-35 Sanford Ave., Queens, NY, and [5] he continues to be employed (as a Translator at the UN (5) Secretariat. In May, 1959, MISHUKOV requested permission (5) to use NY T-4's name and address to receive mail; thereafter he encouraged NY T-4 to seek employment with US State Dept. to aid Soviets; however, in March, 1960, NY T-4 reported he was discontinuing his association with MISHUKOV and as far (as is known, they have had no subsequent meetings. summary of MISHUKOV's activities information about his CS (associates and contacts, and data re his checking account set forth.

I BACKGROUND (W)

A. (Arrival and Departure Data) 5

Records, Visa Division, United States Department of State, Washington, D.C., reflect that in September, 1957, United Soviet YURIY AIEKSENVICH MISHUKOV requested a visa to enter the States as an employee of the United Nations (UN), New York (S) City. These records also reflect that in August, 1958, a visa was issued to ROZA ALEKSEEVNA MISHUKOVA) to enter (S) the United States to Join her husband.

Records, Immigration and Naturalization Service (INS), 20 West Broadway, New York City, reflect that MISHUKOV (S) first arrived in the United States on November 20, 1957, and his wife arrived later on August 15, 1958.

These records further reflect that the MISHUKOVS, [5] accompanied by their daughter, TAMARA, departed the United 5 States on June 1, 1960, aboard the "RMS Queen Mary". However, they (re-entered this country) on September 14, 1960, aboard [5] Scandinavian Airlines System, Flight number 911, at New York International Airport.

B. Residence Data (% (u)

on March 10, 1960, NY T-1 reported that (YURIY) [5] and (ROZA MISHUKOV) planned to obtain an apartment in Queens, (5) New York, upon their return from home leave in the fall of (5) 1960.

On September 19, 1960, Mr. WILLIAM LEVITT, Manager, Colonial Hotel, 51 West 81st Street, New York City, advised SA JOHN T. MULHERN that Soviet national YURIY A. MISHUKOV SI and his family had moved into Apartment 405 at that hotel (3) on September 14, 1960. According to Mr. LEVITT, MISHUKOV (3) did not indicate how long he would remain, and as a result was paying rent on a weekly basis in advance, at the rate of \$47.50 per week.

On October 11, 1960, NY T-2 reported that Soviets (S)
YURIY A. MISHUKOV, BORIS I. BUKATIY and IVAN A. BELOV were
scheduled to move into the Grenoble Apartments, 132-35 Sanford (S)
Avenue, Flushing, Queens, New York, on October 12, 1960.
According to the informant, each of these Soviets was to have (S)
a separate apartment and had signed a two-year lease rather
than the customary three-year one. NY T-2 explained that
these Soviets had been allowed to do this because of the (S)
fact that they had two-year contracts at the UN. Informant (S)
further advised that MISHUKOV and his family were scheduled to occupy Apartment (515) at this establishment at a rent of (S)
\$128.00 per month.


Soviet national BORIS I. BUKATIV is currently (5) employed as a Translator in the Russian Section, Language and Meetings Service, Office of Conference Services, UN Secretariat, New York City.

(Soviet national IVAN A. BELOW is also currently employed as a Translator at the UN Secretariat. (5)

C. Employment Data (X/u)

On September 26, 1960, NY T-3 reported that Soviet (5) national YURIY A. MISHUKOV had returned to the United States (5) from home leave earlier that month and had taken up his duties as a Translator in the Russian Section, Language and (5) Meetings Service, Office of Conference Services, UN Secretariat. According to the informant, MISHUKOV "locked (5) terrible", having lost a lot of weight, and he appeared to be very nervous.

NY T-3 further reported that MISHUKOV was one of Start (Soviets) employed at the UN, who were scheduled to start (Soviets) working the night shift beginning that week. Informant explained that these Soviets would work a 3:30 p.m. to 12:00 (Something that shift and would alternate between one week of nights and one week of days. Informant added that when working the night shift the Soviets work week would run from Monday (Something the priday, but that when they worked the day shift, their work week would run Monday through Saturday, with a day off of their own choosing during the following week.


On a number of occasions since his return to the United States on September 14, 1960, MISHUKOV has been observed by Special Agents of the Federal Bureau of Investigation (FBI) to travel about in the New York City area in a 1955 green Chevrolet sedan, bearing 1960 New York license #804049. Attention is called to the fact that the records of the New York State Motor Vehicle Bureau reflect that MISHUKOV is the owner of this vehicle.

II CONNECTION WITH THE SOVIET INTELLIGENCE MOVEMENT (5.7)

on May 28, 1959, NY T-4 reported that during a meeting which he had with Soviet YURIY A. MISHUKOV on May 23, 1959, the Soviet requested permission to utilize informant's so name and address to receive mail. MISHUKOV explained to Some NY T-4 that he felt that his personal mail was closely so scrutinized by United States Government officials and inasmuch as he did not want to get anyone in trouble, he desired to receive his mail through NY T-4. (MISHUKOV) further told so informant that this mail would come from the Boston, so Massachusetts, area, and pointed out that the only people who would know about it would be himself (MISHUKOV) NY T-4, and the person sending the letters.

Subsequently, on October 6, 1959, NY T-4 reported that he had received a letter for MISHUKOV. This letter was (5) addressed to the informant, utilizing the incorrect middle initial "V." as had been previously agreed upon by NY T-4 and MISHUKOV. This letter was postmarked Boston 5, Massachusetts, (5) and was dated October 3, 1959. NY T-4 turned this letter over to MISHUKOV on October 7, 1959.

In the months following May, 1959, NY T-4
periodically reported that MISHUKOV had encouraged him to
seek employment with the United States Department of State, ()
or some other sensitive government agency, so that he (the ())
informant) would be in a better position to aid the Soviets (5)





Also, during this period, (MISHUKOV) gave NY T-4 instructions (5) concerning security precautions to be followed in connection (5) with (their meetings (5)

As late as February 3, 1960, (MISHUKOV) promised (5)


NY Tall that they would pay him a sum ranging between \$100.00 and \$150.00 a month for his services. It was also indicated to the informant that the Soviets would (5) supplement his income up to \$500.00 per month if he would quit his then current job and attend school in either Washington, D.C., or Boston, Massachusetts, for the purpose of preparing himself for a job (with the United States State Department.)(5)

However, on March 16, 1960, NY T-4 reported that due to "emotional and health problems", he had made up his mind to discontinue his association with MISHUKOV. () Informant further indicated that he planned to attend no further meetings with the Soviet, but pointed out that should (S) MISHUKOV seek him out he would tell the Soviet that he could (S) not go on with their meetings.

Subsequently, on May 29, 1960, NY T-4 reported that (MISHUKOV) had contacted him by telephone in an effort to set of up a meeting prior to his (MISHUKOV's) departure for the Soviet Union on home leave. Tentative arrangements were made for a meeting on May 29, 1960; however, informant advised that he did not plan to actually attend this meeting and reiterated his intention to sever his association with (MISHUKOV.(S))

III ACTIVITIES (50(U)

On several occasions during the period from September 15, 1960 through November 1, 1960, Special Agents of the FBI observed routine travels on the part of MISHUKOV (between his place of residence) (first The Colonial Hotel, 5) bl West 81st Street, New York City, and thereafter, the Grenoble Apartments, 132-35 Sanford Avenue, Flushing, Queens, (5)

New York) and his place of employment at the UN Building, 42nd Street and 1st Avenue, New York City; and between 450 the UN and the headquarters of the Soviet Delegation to the UN, 680 Fark Avenue, New York City. On a majority of these occasions, (MISHUKOV) was observed to utilize his 1955 green Chevrolet, 1960 New York license #80 4049. In a number of cinstances he travelled along on several occasions, he travelled in the company of other Soviet nationals employed (5) at the UN.

In connection with his visits to the Soviet Delegation to the UN, attention is called to the fact that MISHUKOV, during the period from September 15, 1960 to [5] November 1, 1960, visited this establishment on 17 occasions. These visits varied in length from 11 minutes on October 11, [5] 1960 to 3 hours and 44 minutes on October 20, 1960. Nost [5] of them occurred on weekdays (only 3 visits occurred on [5] (weekends) and in a majority of cases the visits took place (s) during the evening hours following MISHUKOV's work day at [5] the (UN Secretariat.)

IV CONTACTS AND ASSOCIATES (X)

A. Former (X (u)

with bushka howarth (6)

On May 9, 1960, NY T-5 identified DUSHKA HOWARTH, Secretary for a Securities Dealer in New York City, as one of several single girls who attended a party held on May 6, 1960, at the residence of ANTONIA PAULE, 246 (5) (East 32nd Street, New York City. N. Yaccording to the informant, C5) three (Soviet nationals employed at the UN attended this (5) party and (Miss HOWARTH spent a considerable portion of the C5) evening dancing with one of them, (Soviet YURIY A. MISHUKOV. (5)

On July 11, 1960, CYNTHIA ANN HOWARTH, also known as DUSHKA HOWARTH, 226 East 7Cth Street, New York City, Strentshed the following information to SAS CHARLES S. FULKS and JOHN T. MULHERN about her past association with YURIY A. MISHUKOV:

She advised that early in May, 1960, she attended a party given by a friend, ANTONIA PAULE, an employee of (5) the Free Europe Committee, 2 Park Avenue New York City(5) At this party, she ran into Soviet national BORIS I. BUKATIY, whom she had previously met at a meeting of the International Friendship Club in September, 1959. (BUKATIY) introduced (5) her to fellow Soviets YURIY A. MISHUKOV and LEONID A.

On a number of occasions during this party Miss (3) HOWARTH engaged in conversation with YURIY A. MISHUKOV and (5) they danced together frequently. According to Miss HOWARTH, (5) her conversations with MISHUKOV were purely social in (5) nature. She explained that she speaks a few words of the Russian language and that their conversations consisted (5) primarily of how to pronounce various Russian words.


Miss HOWARTH concluded the July 11, 1960 interview [5] by advising that she had heard from none of the above-identified (Soviets) since the May, 1960 party. [5]

Prior to his departure from the United States on (5) June 1, 1960, (Soviet LEONID A. KOVALEV) was (5) employed as a Translator in the Russian Section, (5) Language and Meetings Service, Office of Conference Services, United Nations Secretariaty New York City. (**)

According to NY T-6, (KOVALEV engaged in Soviet (5) intelligence activities while in the United States and employed at the (UN Secretariat.)(5)

With AMERICO SALEBE (*(u)

On April 19, 1960, NY T-7 reported that during a recent conversation with AMERICO SALEBE, identified as a former Colombian national, and an employee of the Lockheed Aircraft Company at the New York International Airport, he (informant) learned that SALEBE was acquainted with several Soviets employed at the UN. According to the informant, SALEBE related that from the summer of 1958,

to the summer of 1959, he had attended several parties given by LIBBY HOLMAN REYNOLDS, a wealthy socialite and had taken (Soviets YURIY MISHUKOV, LEONID KOVALEV and VADIM (Last Name Unknown) to some of these parties.

NY T-7 further advised that SALEBE stated that he had met the Soviets through his roommate X DENNIS HARBER, a former English Instructor at the Berlitz School of Languages, Rockefeller Center, New York City. XSALEBE told informant that a number of Soviets had been enrolled in HARBER's English classkin the past and that he had met several of these individuals

On April 20, 1960, NY T-8 reported that during a party which he attended on April 16, 1960, he had overheard AMERICO SALEBE talking to Soviet national LEONID A. KOVALEV. (S) According to the informant; SALEBE asked KOVALEV about YURIY MISHUKOV. KOVALEV answered that MISHUKOV was fine (S) and that he would tell YURIY that he had seen SALEBE at the party.

On July 21, 1960, and August 11, 1960, AMERICO JOSEPH SALEBE, who resides at 454 West 22nd Street, New York City, and is employed as an Aviation Electrician at Lockheed Aircraft Service International, Incorporated, New York International Airport, Jamaica, Queens, New York, furnished the following information concerning his past association with Soviet nationals employed at the UNITY Special Agents (5) FRANKLIN B. TEETER and RICHARD W. HILL:

Shortly after immigrating to the United States from Colombia, Central America in 1956, SALEBE net, and became a roommate of DENNIS L. HARBER, an English Instructor at the Berlitz School of Languages, Rockefeller Center, New York City. HARBER had as students at the Berlitz School, a number of foreign nationals, among whom were several Soviets. To HARBER often talked to SALEBE about the fact that he had Russians as students and explained that they were in effect, international civil servants as they worked for the United Nations organization rather than being members of the Soviet Union's Delegation to the United Nations. SALEBE met only two of these Soviets, and under the following circumstances:



The first Soviet he met was introduced to him as LEONID KOVALEV by HARBER. XSALEBE met this individual in the spring of 1958 when he accompanied DENNIS HARBER to the Berlitz School.


He next saw KOVALEV sometime during the summer of 1958, when he attended a party on West 79th Street, New York City, which was given by Miss ANNETTE EPSTEIN, another Instructor at the Berlitz School.

Also present at this party was another Soviet (5)
national who was introduced by KOVALEV as "GEORGE" and
further identified as a fellow worker at the United Nations
Secretariat. During the course of the evening, SALEBE (5)
conversed on several occasions with both KOVALEV and
"GEORGE". These conversations were purely social in (5)
nature; however, at one point he conversed in Spanish with
(5) "GEORGE", who told him that he (the Soviet) had learned (5)
Spanish while serving in Spain in 1934 and/or 1935.

5) "GEORGE" did not explain what work he was doing in Spain.

Following the party given by ANNETTE EPSTEIN, SALEBE saw Soviet LEONID KOVALEV on a number of occasions, either at the Berlitz School or when the Soviet came to (5) his and HARBER's apartment for English lessons.

His next contact with KOVALEV occurred in the Spring of 1959. Sometime in March, 1959, Mrs. LIBBY HOLMAN REYNOLDS invited SALEBE to an art exhibition to be held at a gallery on Madison Avenue. SALEBE explained that Mrs. REYNOLDS was a wealthy woman he had met some five years previously when he operated a Hi Fidelity Repair Shop. She was referred to him by another customer and had utilized his services both in connection with Hi-Fi systems in her New York City apartment and her home in Connecticut. As a result of doing work for Mrs. REYNOLDS, she had invited him to several cocktail parties and other such affairs.





In addition to inviting him to the art exhibition,
Mrs. REYNOLDS told SALEBE that she was planning a tour of
the Far East and wanted to include the Soviet Union in this
tour. She asked if SALEBE on DENNIS HAREER knew any Soviets
who might be able to give her some ideas as to the type of
entertainment which would be accepted in the USSR.


As a result of Mrs. REYNOLDS' request, SALEBE contacted KOVALEV by telephone at the United Nations. He sexplained to the Soviet what Mrs. REYNOLDS wanted and invited him to the art exhibition. KOVALEV stated he would be glad to talk to Mrs. REYNOLDS and they agreed to meet at the art gallery.

Following the exhibition, SALEBE and KOVALEV (5) attended a party given by LIBBY HOLMAN REYNOLDS at her New York City apartment. During this affair, Mrs. REYNOLDS talked about her proposed tour with KOVALEV in SALEBE's(5) presence. [KOVALEV] told Mrs. REYNOLDS that he did not think (5) that the type of concert she was planning would be very well received in the USSR and also stated that he did not believe (5) she could arrange it funder the official exchange program between the United States and the Soviet Union. However, (5) he told her that if she still wanted to try and arrange it she should contact the Intourist organization.

SALEBE's last contact with KOVALEY occurred in April, 1960, when he attended a party held at the residence of BURTON FOREMAN on Claremont Avenue near Columbia University, New York Pity. NSALEBE identified FOREMAN as a former Instructor at the Berlitz School of Languages who currently taugh: Japanese at Columbia. He further explained that he had met ______at the party given by ANNETTE EPSTEIN during the summer of 1958, and did not know him well, adding that it was ANNETTE EPSTEIN who invited him to the April, 1960, party

OTHER 4

SALEBE advised that he arrived at the party at approximately 10:00 p.m. and knew few of the people present. However, KOVLAEV showed up at the affair 3) approximately one hour later, and they visited together socially on several occasions. [KOVALEV] left the party, alone,





at 12:30 p.m. SALEBE remained at the affair until it ended at approximately 4:00 a.m. and spent most of the time dancing with a girl introduced to him by ANNETTE EPSTEIN.


Following the above resume of his contacts with (S) KOVALEV, SALEBE advised that all of his contacts with this soviet had been purely social in nature and "above board". He added that KOVALEV had at no time asked him about his job (5) at the New York International Airport and in fact had no unusual requests. SALEBE stated that he considers himself a loyal American, even though he is a naturalized citizen, and would have discontinued his association with KOVALEV, (5) limited as it was, if the Soviet had acted suspicious in (5) any way.

Concerning "GEORGE," SALEBE advised that he had only met and talked with this Soviet on the one occasion, the (S) party given by ANNETTE EPSTEIN during the Summer of 1958. However, he stated that from remarks that KOVALEV had made (S) he got the impression that "GEORGE" was also present at the March, 1959, art exhibition, although if so, he, "GEORGE" did not attend the party held afterwards at LIBBY HOLMAN REYNOLDS apartment.

During the course of the above interviews, SALEBE positively identified a photograph of Soviet national LEONID AFANASIEVICH KOVALEV as the LEONID KOVALEV he had met through DENNIS HARBER. He further positively identified a photograph of Soviet national YURIY ALEKSEEVICH MISHUKOV as the Soviet known to him as "GEORGE" (5)

With PAUL WONNACOTT (X) (U)

In January, 1960, NY T-1 reported that PAUL WONNACOTT, identified as an Economics Instructor at Columbia University, and a part-time employee at the UN Secretariat, was one of a few Americans who attended the Christmas party given by the Soviets at the UN on December 23, 1959, and had met Soviet Translator YURIY A. MISHUKOV at this party (5)





Informant further advised that subsequently on January 11, 1960, WONNACOTT had lunch with MISHUKOV at the UN Cafeterial (6)


On October 5, 1960, GORDON PAUL WONNACOTT, 25 Claremont Avenue, New York City, an Instructor of Economics at Columbia University, who was formerly employed from October, 1959 to March, 1960, as an Economic Consultant at the UN, furnished SA FRANKLIN B. TEETER and SA ARTHUR H. SEIDEL with the following details surrounding his original meeting and subsequent contacts with Soviets employed at the UN.

WONNACOTT advised that during the Christmas season of 1959, he attended a number of parties at the UN, one of which was given by the Soviets. The stated that he did not recall whether he received a specific invitation to the Soviet Christmas party, but advised that he felt that in all probability he had not. He explained that most of the Christmas parties at the UN were open affairs with many people coming and going.

WONNACOTT advised that during the Soviet Christmas party he met a number of Soviet nationals briefly, but did on not recall most of their names. He pointed out that he did recall meeting a Soviet couple, Soviet Translator YURIY A. MISHUKOV and his wife, ROZA, the furnished the following information about his conversations with this couple:

WONNACOTT explained that his conversations with YURIY and ROZA MISHUKOV were primarily social in nature. However, on one occasion during the Christmas party, they engaged in a discussion of Marxism and the basic theories behind Communism. According to WONNACOTT, he took the opposite side from the MISHUKOVS and made a special point of calling to their attention the inconsistencies in the Soviet system. WONNACOTT related that this discussion became quite involved at times, but never reached the argumentative stage.

WONNACOTT advised that during the months followingthe Soviet Christmas party, he had lunch on several occasions
with MISHUKOV at the UN. He was unable to furnish the number or the exact dates of these luncheon engagements, but stated
that he did recall that the first one took place in early
January, 1960 and the last one occurred in the latter part
of April, 1960.

WONNACOTT stated that to the best of his recollection, his conversations with MISHUKOV during these luncheon engagements (5) dealt with a variety of subject's ranging from an exchange of purely social amenities to rather prolonged discussions of world affairs. WONNACOTT advised that during this latter type of discussion he went out of his way to let the Soviet (5) know that he was opposed to Communism and to the Soviet Union's approach to international relations.

WONNACOTT advised that his last contact with [MISHUKOV] occurred on May 14, 1960, when the Soviet invited him to attend a "going-away party" for BORIS BUKATIY and several other Soviets. This party was held at BUKATIY'S (S) residence in Queens, New York, and according to WONNACOTT was purely a social gathering. WONNACOTT stated that he met several new Soviets there, but was unable to recall their names.

WONNACOTT concluded the October 5, 1960, interview by advising that he had not heard from MISHUKOV since the May 14, 1960, party and, in fact, did not know if the Soviet was still in New York City. He explained that during the May 14, 1960, party, MISHUKOV had told him that he was scheduled to return to the Soviet Union on home leave in the hear future.

B. Current (4)(U)

With NY T-9 (u)

Cn August 26, 1960, NY T-9 reported that he had returned to New York City on August 1, 1960, following an extended vacation in Europe. He stated that he had not heard from Soviet YURIY A. MISHUKOV since his return and pointed out that he did not actually know if MISHUKOV himself had

returned to the United States from home leave. Informant stated that he presumed MISHUKOV would contact him as 6 promised during their last meeting in April, 1960.

On October 28, 1960, NY T-9 reported that he had been in telephonic contact with MISHUKOV at the UNJon the previous day. He intited the Soviet to attend a Halloween party being given on October 28, 1960, by the Washington Square College Evening Organization of New York University (NYU). According to the informant, MISHUKOV was quite friendly and accepted the invitation even though he told NY T-9 that he was working the night shift at the UNJ (S)

NY T-9 further reported that during his October 27, 1960, conversation with MISHUKOV, he pointed out to the (5) Soviet that the Human Relations Forum Club (HRFC) at New York University had been revived. Informant asked (MISHUKOV) if it would be possible for him or some other Soviet official at the UN to address a future meeting of the HRFC. MISHUKOV approved of the idea, but no definite arrangements were made. Along this line, NY T-9 stated that he also invited MISHUKOV to attend the next meeting (5) of the HRFC scheduled for Thursday evening, November 3, 1960, and the Soviet accepted this invitation.

On November 1, 1960, NY T-9 reported that

(MISHUKOV did not show up at the NYU Halloween dance on
October 28, 1960, and had not contacted the informant
since that date to explain his absence. Informant stated
that he had hopes that the Soviet would attend the S)
November 3, 1960 meeting of the HRFC and advised that he
planned to contact MISHUKOV by telephone to remind him of
this meeting.

However, on November 8, 1960, NY T-9 reported that he had been unable to reach MISHUKOV by telephone prior to the meeting of the HRFC and that MISHUKOV had not shown up at this meeting. Informant advised that he still planned





to contact MISHUKOV in the near future for the purpose of ascertaining if MISHUKOV or some other Soviet official (S) would address a future meeting of the HRFC.

With NY T-1 XW

On October 20, 1960, NY T-1 reported that he had had only one contact with Soviet YURIY A. MISHUKOV since (5) the latter had returned to the United States from home (5) leave. Informant furnished the following details about this contact.

A few days before October 20, 1960, informant met MISHUKOV in the halls of the UN Building and they had a brief conversation. MISHUKOV Told NY T-1 that he had acquired an apartment in Queens, New York, but pointed out that he and his wife were not residing with the BUKATIYS as they had previously planned. (S)

MISHUKOV asked NY T-1 to aid in registering ROZA MISHUKOVA in an English course at the UN. Dinformant agreed to do this, but no mention was made of ROZA's taking private English lessons from NY T-1 as she had done in the past.

NY T-1 advised that MISHUKOV further mentioned during their contact that he planned to have a housewarming party for his new apartment in the future, but no specific date was set.

With Others (X)(U)

On October 20, 1960, NY T-10 reported that he had attended a party given by MARIA LIPTON, 8337 James Avenue, Elmhurst, Queens, New York, on October 14, 1960. Informant further identified MARIA LIPTON as a single girl of Russian heritage, whom he has known for several years and who is employed in the Wall Street area in New York City. According to NY T-10, two Soviet nationals were present at the referred to party and he furnished the following details about his contacts with these Soviets: (5)


Informant stated that during the course of the evening he was introduced to the two Soviets and one of them identified himself as (BORIS BUKATIY) while the other was only identified by his first name, (YURIY) According to NY T-10, his conversations with these Soviets consisted primarily of a discussion of the Soviet as compared to the (American system of government) This resulted in a "mild" argument with the informant taking the opposite view of the Soviets.

Informant advised that during the evening BORIS BUKATIY gave him his UN telephone number (5) Also, both of these Soviets exhibited interest in the informant's background when they learned that he could speak Russian (5) According to NY T-10, he untruthfully told the Soviets that he was so born in the United States although his parents were born in Russia (5)

Informant advised that the only other persons he knew at the October 14, 1960, party, besides MARIA LIPTON, were MARINA MASLENIKOW, who resides at 500 West 110th Street, New York City, and NATASHA KISELEY (phonetic). (S) / Informant identified both of these women as employees of the UN. (S)

NY T-10 concluded the October 20, 1960 interview by advising that he had not seen the two Soviets arrive at the October 14, 1960 party, but advised that they spent at least an hour there. They left together prior to the departure of the other guests.

Subsequently, on October 25, 1960, NY T-10 positively identified photographs of BORIS IVANOVICH BUKATIY and YURIY ALEKSEEVICH MISHUKOV as the Soviets he met at the October 14, 1960 party, Also, on this occasion, he advised that he had learned from MARIA LIPTON that the two Soviets (s) had been invited to the party by NATASHA KISELEV (phonetic) had been added that, although he was not positive on this point, he was fairly certain that Miss KISELEV (phonetic) had not left the party with MISHUKOV and BUKATIY.





According to the pamphlet entitled, "Staff of the United Nations Secretariat; Report of the Secretary General", dated September 30, 1960, and issued by the UN General Assembly, Miss MARINA () MASLENIKOV, a United States national, is employed in the Service to Readers Section of the UN () Library. This pamphlet further reflects that Miss NATALIE KISSELEFF, a United States national, is employed as a General Service employee in the Division of General Economic Research and Policies, Department of Economic and Social Affairs, UN Secretariat. (5)


