During interview with Dr. PULIDO on 9/23/76, he advised that he had no knowledge of Dr. ARMANDO LOPEZ MOLINA, who previously had been identified as one of the collectors of money in the New York-New Jersey area for Dr. ORLANDO BOSCH AVILA, who currently is incarcerated in Caracas, Venezuela. (u) [NK 5006-S, NK 2622-S and NK 5775-S were contacted on 10/28/76, and again on 11/2/76 and they advised that they had no knowledge of the identity or current whereabouts of Dr. ARMANDO LOPEZ MOLINA.
