TEOFILO BABUN FRANCO

Appears identical with subject of Miami file 2-347,  
a well-to-do Cuban exile who was engaged in shipping business  
in Cuba and who is connected with ship repair yard in Miami.

OSCAR FERNANDEZ VIEGO

CIA in publication dated 10/10/62 classified  
"Secret" identified one Oscar Fernandez Reiga as a leading  
personality in Ejercito Libertador de Cuba, an anti-Castro  
organization. (S-1)(X)(U)

SELECTED CUBAN GOVERNMENT LEADERS

ELISEO GOMEZ FERNANDEZ

Identical with individual who is being considered for development as PSI in Dominican and Cuban fields by Miami Office, Miami file 134-916. Miami letter 4/21/64 in this matter also reports information concerning Teofilo Babun, mentioned above, and Oscar Fernandez, who appears identical with Oscar Fernandez Viego mentioned in attached CIA communication. JED (u)

In view of alleged involvement of Gomez in plan to assassinate Cuban Government officials, no further consideration should be given to developing him as PSI.

JOSE "PEPIN" BOSCH

Appears identical with Jose M. "Pepin" Bosch, President of Bacardi Rum Company, who has recently been active in the Pro-Referendum Committee, another anti-Castro group, Miami file 105-8280.

JULIO LOBO OLAVARRIA

Appears identical with Julio Lobo who is subject of London, cables dated 6/23, 29/61 and London letters 7/3, 12, 31/61, copies of which have been furnished New York, Bufile 105-100379. Lobo was formerly known as Cuban sugar king and his holdings were confiscated by Castro.

Recipient offices promptly advise Bureau of any information they may have in this matter and keep Bureau advised of any information received. No other investigation desired.
