Re Dallas letter to Bureau, 7/10/63.

On 7/17/63, PHILIP STEPHENS BOSCO (DL 165-92),
[redacted] (DL 165-37) and MARVIN RALPH MARSHALL
(DL 165-134) were arrested by officers of the Dallas PD
Vice Squad on charges of vagrancy and investigation
of bookmaking. They were arrested on information
furnished the Dallas PD by the Dallas Office as to their
operations and locations. Following their arrest, each
man was interviewed separately at the Dallas PD. MARSHALL
and BOSCO were quite hostile and appeared to be very upset
over being arrested. Both refused to furnish any informa-
tion or discuss their gambling activities or their back-
ground in any manner. [redacted] on the other hand appeared to
be quite cordial and receptive towards development as an
informant. He stated he would assist the FBI on a confidential
basis in furnishing information concerning gambling activities
in the Dallas area. Dallas has opened a new 137 case con-
cerning [redacted] and will continue efforts to develop [redacted]
as an informant.
