Careful consideration has been given to each source concealed and T symbols were utilized in the report only in those instances where the identities of the sources must be concealed.

Information furnished by T-5, identified as Mr. CHRISTINE VOEGELE, was made available by him upon his supposition the material referred to in the details of this report was abandoned. Following examination of the material the building superintendent, Mr. MARION DIXON (T-6) advised that the material had been placed in its location by the subject, and was not abandoned as originally believed to have been by VOEGELE. In view of the nature of the information and the manner in which it was obtained, it was deemed advisable to cover both VOEGELE and DIXON by T symbols.

The other confidential informants referred to in this report under the heading Miscellaneous, who were contacted with negative results, are as follows:

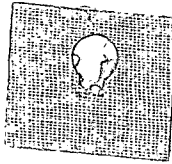
